# Town of Niagara Town Board Minutes at Special Meeting August 12, 2025

On August 12, 2025, at 7:50 p.m., Town Board Member Michael Lee voted to convene a special meeting of the Town Board to address an emergency resulting from a fire at 6309 Manor Road. The motion was seconded by Town Board Member Johnny Parks. The motion was passed unanimously by all three Board members in attendance including Deputy Supervisor Marc Carpenter.

A presentation was made by Code Enforcement Officer Charles Haseley concerning the dangerous and unsafe condition resulting from a fire at the previously condemned building at 6309 Manor Road.

A motion to declare the property at 6309 Manor Road a public nuisance, unsafe and in need of an emergency demolition to protect nearby residents and the public pursuant to Town of Niagara Town Code Section 121(8) and to assess all the costs against the property pursuant to Town Code Section 121(6) was made by Town Board Member Johnny Parks and seconded by Town Board Member Michael Lee. The motion passed unanimously with all three Board members in attendance voting in the affirmative.
